These objectives can only be realized through teamwork and the support of staff.

The combined objectives are as follows:

#### 1. Faculty Assessment:

Faculty Survey: Departmental HODs will conduct a faculty survey, including feedback from faculty members and their evaluation of departmental procedures for teaching, faculty development, and research.

Summary and Reporting: A summary of the survey results, along with planned and implemented corrective actions, will be submitted to the Medical Education Department and the QEC.

Frequency: Surveys will be conducted at least every six months.

#### 2. Departmental Review and Accreditation:

Performance Review: QEC will review the performance of each department based on reports from the Departmental Heads based on quality teaching and training for students through regular reviews and assessments..

Annual Review: Conduct annual reviews using standard parameters set by each department.

#### 3. Maintain Liaison with Departments:

Communication: QEC will maintain liaison with Departmental Heads to identify issues and gaps in meeting quality standards. Meetings will be scheduled with the Departmental Heads at least once every 6 months.

Solutions: Suggest strategies and solutions to Departmental Heads to overcome existing gaps and issues.

#### 4. Student Feedback:

Feedback Mechanism: HODs will conduct student surveys using standardized forms disseminated by the QEC Chairperson.

Summary and Reporting: A summary of the survey results, along with planned and implemented corrective actions, will be submitted to the Medical Education Department and the QEC.
